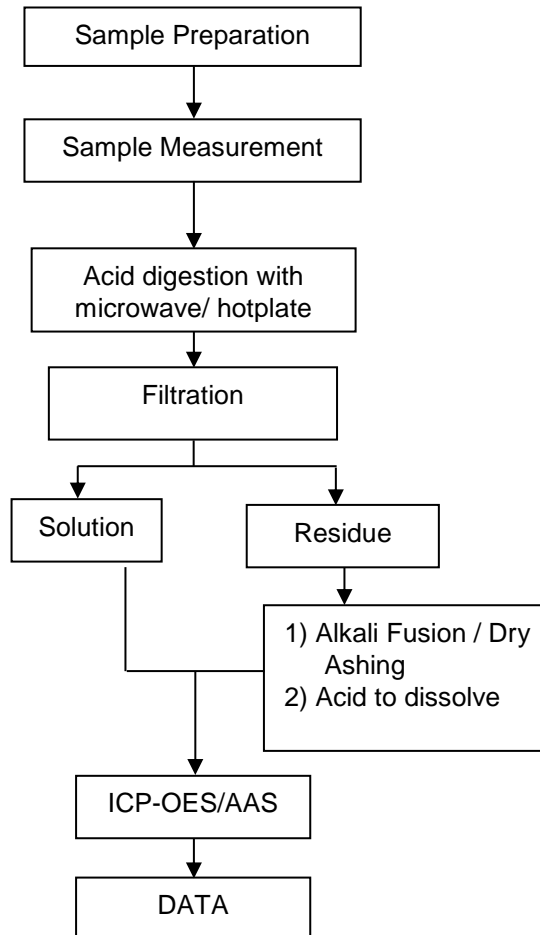

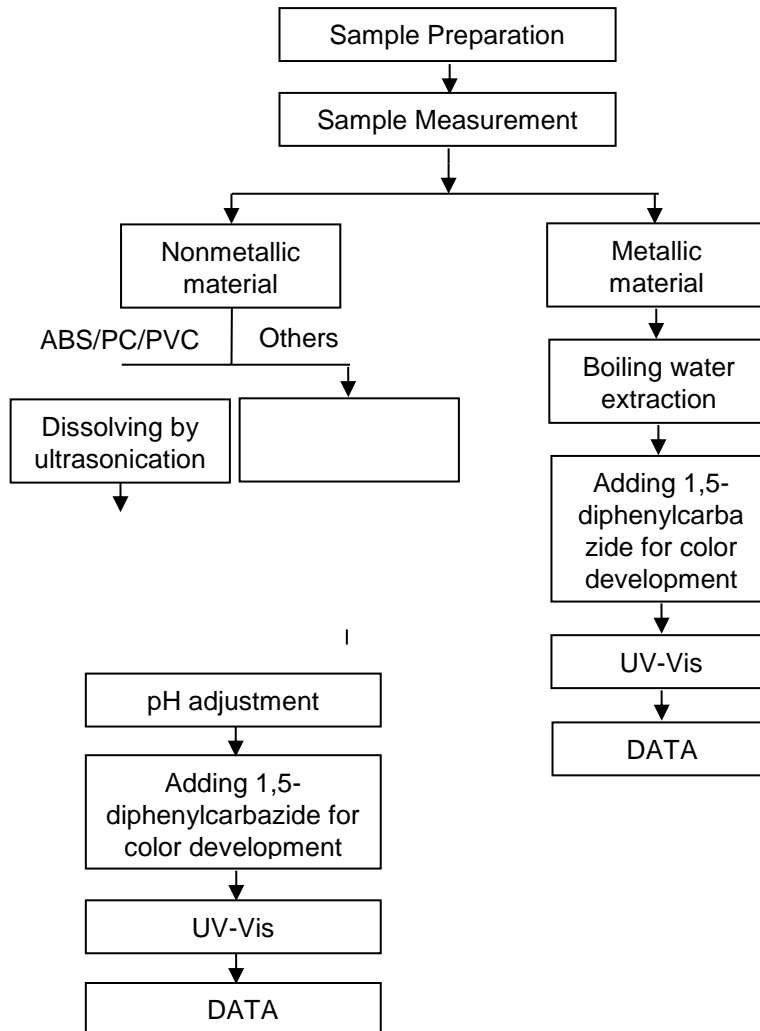

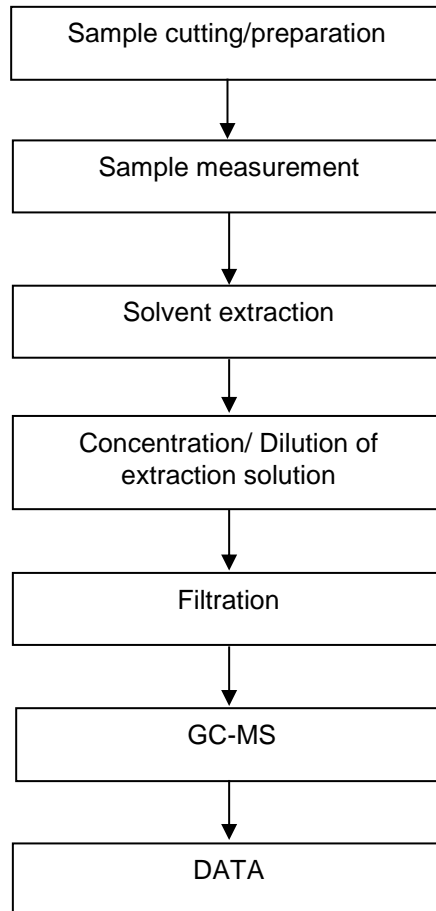

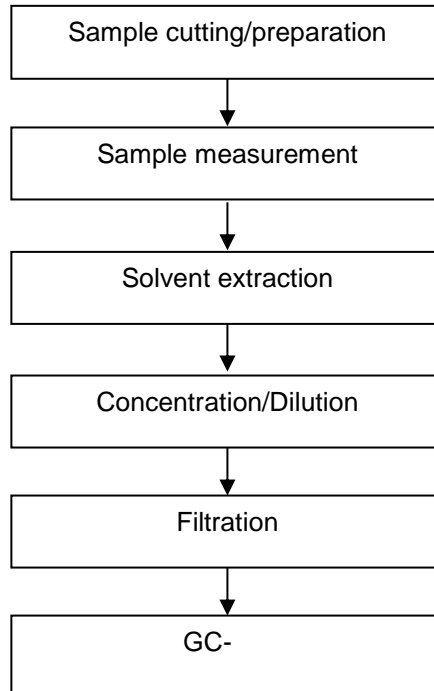

Halogen Testing Flow Chart

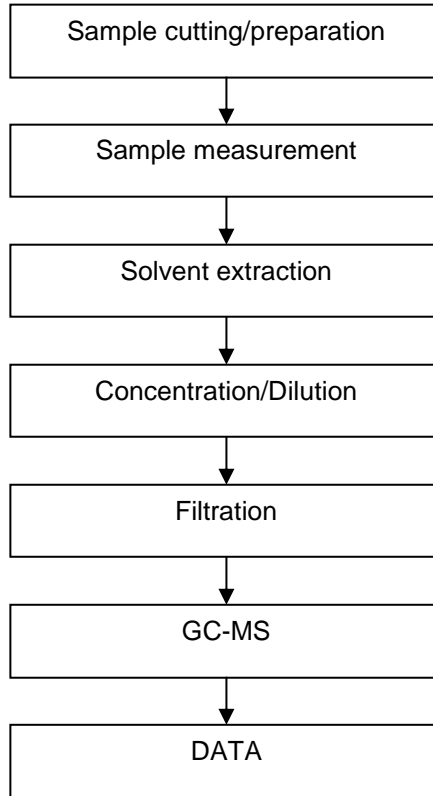

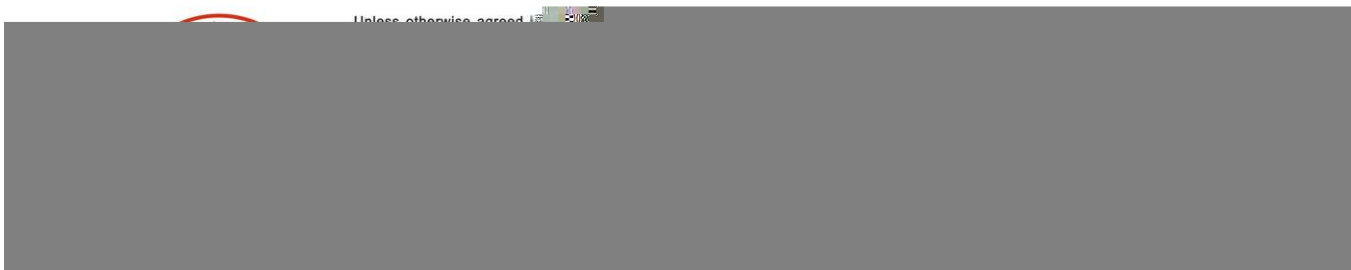
